PARTY OF EIGHT raced close up off the rail and weakened a bit. LOVE DIVINE lacked a rally. LEAWOOD set the pace off the rail and tired. DAYTIME PLEASURE raced close up off the rail and gave way. POWDER RIVER lacked speed and was not a factor. MISS ANN H also failed to reach contention. ASESINA gave way in the drive. RACE RUN IN LANE 3, RAIL OUT 6 FEET.
