SILVERFOOT raced wide early, waited for room in the drive, angled in and was up in the final strides. PUBLIC SPEAKER raced in the second flight, put his head in front, came over and bumped GENERAL CHARLEY and just missed. EMBOSSED (IRE) made a quick move in the second turn and was gaining while wide. GENERAL CHARLEY raced wide early, edged to leaders in the stretch, steadied and was bumped which resulted in the jockey claiming foul. VALTRUS saved ground, steadied late in the drive and was gaining when clear. TELLING raced evenly, raced seven wide in the stretch. TIGER WOODMAN was taken back at the start and passed tiring rivals. SNAPPHOK had no speed and failed to menace. RUMOR HAS IT set the pace, was unchallenged early and used up. ELECTRICITY had no speed and not a threat. RACE RUN IN LANE 1. THERE WAS A STEWARD'S INQUIRY AND JOCKEY'S CLAIM OF FOUL WHICH RESULTED IN THE DISQUALIFICATION OF PUBLIC SPEAKER FROM SECOND TO FOURTH FOR INTERFERENCE IN THE STRETCH.
