GENERAL CHARLEY was urged to the fore while making his way to the inside in the opening furlong, set the pace under light rating racing to the far turn, turned back a challenge to shake clear entering upper stretch and widened his advantage under some right handed taps and steady encouragement. UNPAID CRUSADE, held up off the second flight while angling to the inside racing to the first turn, shifted out nearing upper stretch to challenge three deep, couldn't gain terms with the winner but prevailed for the place. AKA LILY'S LAD angled to the inside early tracking the leaders as part of the second flight while under some reserve, saved ground to upper stretch while making some effort to challenge and was outfinished for the place. ANTRIM COUNTY moved to terms with the pacesetter racing into the first turn, attended the pace for a half, pressed the leader racing into the far turn and gave way entering upper stretch when proving no match. REY DEL SOL tracked the leaders just off the inside as part of the second flight to the backstretch but weakened nearing upper stretch. PAISANO CREEK tracked the pace unhurried along the inside and offered no rally. HIGH SPIRIT trailed.
