FOUR YEAR OLDS AND UPWARD. Free nomination by Saturday, March 4. \$1,000 to enter. \$100,000 Guaranteed A supplemental nomination fee of \$100 may be made prior to closing time of entries. After payment of 1% to all owners of horses finishing sixth through last, 62% of the remaining purse shall be paid to the owner of the winner, 20% to second, 10% to third, 5% to fourth, and 3% to fifth. Weight: 124 lbs. Non-winners of a graded stakes since September 1 allowed 2 lbs.; a stakes race since June 1, 4 lbs.; three races other than maiden, claiming, starter or state-bred allowance, 6 lbs. Starters to be named by usual time of closing. All fees shall be paid prior to the start of the race. Preference will be given to stakes winners 2021-23, stakes-placed 2021-23, non-restricted stakes winners 2022-23, then by highest career earnings. Trophy to the winning owner. (If deemed inadvisable to run this race over the turf course, it will be run on the Tapeta Course at Five Furlongs) (Rail at 49 feet).

BIG INVASION settled off the pace in the four path, was under rousing around the turn and tipped out to the six path at the top of the lane, tipped inwards while rallying under steady encouragement down the lane, and was up for the win in closing strides. YES I AM FREE set the pace inside was roused in the two path around the turn and opened up along the rail into the stretch, stayed on but was caught by an outer foe in closing strides to finish with place honors. CAROTARI stalked along the inside, was coaxed from the rail around the turn, cued left handed in the two path entering the stretch, and ran on between rivals under left handed urging for show. FULL DISCLOSURE prompted the pace in the two path, was under a ride in the three path around the turn, and kept on from the four path in the stretch. NOVGOROD THE GREAT chased in the three path, was under coaxing in the four path around the turn, and finished evenly from the five path in the stretch. OMAHA CITY rated in the five path, fanned out to the seven path while under a drive into the stretch, but was no factor. BELGRANO bumped with an inner foe at the start, was wellback in the three path, under urging while floating out to the center in upper stretch, but was no threat. PANTHER ISLAND tracked in the four path, was cued passing the quarter pole, but faded between foes from the six path in the

stretch. SIGILOSO bumped with an outer foe at the start and trailed throughout.
